PRIVACY POLICY

This privacy policy (**Privacy Policy**) will help you understand what information we collect at VASUDHAIVA KUTUMBAKAM GROUP PRIVATE LIMITED (Formerly known as Leverage Ed-Tech Private Limited)(**Company**), why we collect it, how the Company uses it, including if and how we share the information with third parties, and the choices you have.

When we talk about "we," "our," or "us" in this Privacy Policy, we are referring to the Company. When we talk about "you" in this Privacy Policy, we are referring to the User.

By using the Website and providing your data to the Company, you agree to the terms of this Privacy Policy, for your use of the Website. This Privacy Policy may be modified by the Company from time to time in its sole discretion, and any modifications shall be made effective and binding upon you through posting by the Company on the Website.

By mere use of the Website, you expressly consent to our use and disclosure of your personal information in accordance with this Privacy Policy.

A. INFORMATION WE COLLECT AND RECEIVE

1. Your Data

Your data may contain 'sensitive personal data or information' or 'personal information' as defined under the Information Technology (Reasonable Security Practices and Procedures and Sensitive Personal Data or Information) Rules, 2011 (**Data Protection Rules**). The Company will collect, use, process, and transfer such information as prescribed under the Data Protection Rules. Where the Company collects or processes your data, it does so on your behalf. Your data may include the following types of data, but is not restricted to: name, gender, date of birth, nationality, home address, source of funds, employment status (including industry type), any political exposure or not, email ID, phone-numbers and other contact information.

2. Other Information

- Account creation information: In the course of the usage of the Website, the Users provide information such as an email address and password.
- **Billing and other information:** For transactions undertaken on the Website, our third-party payment processors may collect and store billing address and credit card information.
- Website usage information: This is information about how you are accessing and using the Website, which will include administrative and support communications with us and information about the transactions undertaken through the Website.
- **Contact information:** With your permission, any contact information you share is collected (such as an address book from a device) when using the Website. We may also collect your phone number and email address to contact you. You may also receive SMSs, emails, phone calls, etc., in connection with the Website.

• Third party data: The Company may also receive information from affiliates in our corporate group, our partners, or others that we use to make our own information better or more useful. This might be aggregate level information, such as which IP addresses go with which pin codes, or it might be more specific information, such as about how well an online marketing or email campaign performed.

3. Retention

The information above would be collected and retained by the following entity:

We will not retain any sensitive personal data or information for longer than is required for the purpose for which such data or information was collected or may lawfully be used or is otherwise required under any other law for the time being in force. We may retain anonymized data for as long as is required.

We may provide information to service providers to help us bring you the services we offer. Specifically, we may use third parties to facilitate our business, such as to host the service at a co-location facility for servers. Where we utilize third parties for the processing of any personal information, we implement reasonable contractual and technical protections limiting the use of that information to our specified purposes.

4. Our Cookie Policy

We send cookies (small files containing a string of characters) to your computer, thereby uniquely identifying your browser. Cookies are used to track your preferences, help you login faster, and aggregated to determine user trends. This data is used to improve our offerings, such as providing more content in areas of greater interest to a majority of users.

Most browsers are initially set up to accept cookies, but you can reset your browser to refuse all cookies or to indicate when a cookie is being sent. Some of our features and services may not function properly if your cookies are disabled.

B. PURPOSE OF COLLECTION

The Company may process information including sensitive personal data or information concerning you both internally and externally (so far as reasonably necessary) for the purposes mentioned below (**Purposes**).

You have the option to refrain from disclosing your sensitive personal data or information to the Company. You will also have the option of withdrawing consent previously provided to the Company. 1. Your data

- Sending emails and notifications: By accepting the terms of this Privacy Policy you give us the permission to send you Website notifications and administrative emails and messages including text messages. You hereby consent to receiving text messages from us, however you have the option to opt out later. We may also contact you to inform you about changes on the Website, its offerings, and important Website related notices, such as security and fraud notices. These emails and notifications are considered part of the Website and you may not opt-out of them. In addition, we sometimes send

emails about new service offerings or other news about the Company which we feel might be useful for you.

- **Billing and account management:** We use account data to administer accounts and keep track of billing and payments.
- **Communicating with you and marketing:** We often need to contact you for invoicing, account management and similar reasons. We may also use your contact information (with us) for our own marketing or advertising purposes. You can opt out of these at any time.
- **Investigating and preventing bad things from happening:** We work hard to keep the Website secure and to prevent abuse and fraud.

This Privacy Policy is not intended to place any limits on what we do with data that is aggregated and/or de-identified so it is no longer associated with an identifiable User of the Website.

C. THIRD PARTY CONTENT AND LINKS

We may present links in a format that enables us to keep track of whether these links have been followed. We use this information to improve our customized content. Clicking on links may take you to sites outside our domain. We are not responsible for the privacy practices of other websites. We encourage our users to be aware when they leave our site to read the privacy statements of each and every website that collects personally identifiable information. This Privacy Policy applies solely to information collected by our Website.

D. YOUR CHOICES

1. Your Data

You provide us with instructions on what to do with your data. You have many choices and control over your data. 2. Access to Sensitive Personal Data or Information

- To any government agency if required by law for the purposes of verification of identity, or for prevention, detection, or investigation of crime (including cyber incidents), or for prosecution or punishment of offences;
- Enforce applicable Terms of Use, including investigation of potential violations thereof;
- Detect, prevent, or otherwise address fraud, security or technical issues;
- Protect against imminent harm to the rights, property or safety of leverageedu.com EdTech Private Limited, its users or the public as required or permitted by law. We may share with third parties certain pieces of aggregated, non-personal information, such as the number of users subscribed to a particular product, or the number of users registered on our website. Such information does not identify you individually.

F. TRANSFER

The Company may transfer personal information pertaining to you to third parties for the Purpose. You are expressly notified that the transfer may also be to foreign jurisdictions where your personal information may be processed by third-party service providers and vendors, or our group companies, in relation to the Purpose.

G. MONITORING

The Company will, as far as possible, respect your privacy and autonomy while you use its electronic communication systems.

H. PUBLIC FORUMS

All such sharing of information is done at your own risk. I. SECURITY
